## TREASURER REPORT

DUES ARE DUE! It's that time again.

When you send in your dues, please try to include the dues form. If your dues will be delayed, please inform your treasurer so that an extension may be granted. The Constitutional rules applying to dues follows:

Section 2. "Dues" "Membership dues shall be \$12.00 per year for full membership and \$5.00 per year for juior membership payable on or before the first day of January each year. No member may vote whose dues are not paid for the current year. During the month of November, the Treasurer shall send to each member a statement of his dues for the ensuing year."

Section 4. "Termination of Membership" "Memberships may be terminated by lapsing. A membership will be considered as lapsed and automatically terminated if such member's dues remain upaid 60 days after the first day of the fisical year; however, the board may grant an addition of 30 days grace to such delinquent members at its discretion."

Dues are payable by January 1st. The final cutoff date is March 1st. unless a grace period has been previously granted by the Board. The final grace period is up on April 30, at which time a new roster is printed.

A recent letter from John Best sends us this clipping from a newspaper in Ireland about Bobby Grant (and in John Best's words) who is now 87, founded the Slemish Kennel of Irish Terriers back about 1920, and has bred, exhibited and exported Irish continuously for the past sixty years. As recently as Feb., 1980, Bobby won Best of Breed at Crufts with an Irish Terrier of his breeding.

He is a grand old man, and looks and acts like he's 60. He and I became good friends in 1967 and have remained so.

#### From the Ballymena Guardian:

At 87-years-of-age Mr. Bobby Grant is recognised as one of the world's leading authorities on Irish Terriers.

10. With 60 years' experience and two Best of Breed trophies at Crufts behind him, his dogs and his knowledge are in demand all over the world.

It is activities like this that have put him in line for a £10,000 prize and the title of

Twice he has been a judge at Crufts.

# Rizzo takes on chemical firms

Time was when former Mayor Frank L. Rizzo felt that some environmentalists went too far in their protests and legal actions against chemical companies.

But that was before a morning in July, when Rizzo came down to the kitchen of his Chestnut Hill home to find Casey, his beloved pet Irish terrier, stricken with what Rizzo said yesterday had been diagnosed as poisoning from a lawn-care chemical.

After weeks of slowly nursing the three-year-old dog back to health, including a period when the former mayor<sup>1</sup>said he had literally slept with Casey to keep a watchful eye on the dog, Rizzo has taken on the giants of the chemical industry in a lawsuit that he said he hoped would make the environment safer for wild and domestic animals.

"I was always an environmentalist, and now they have me 100 percent on their side," the former mayor said in a telephone interview last night. "I thought at one time they went too far with their protests, but no more."

In a suit filed Monday in Common

Pleas Court, Rizzo asked that chemical companies be required to develop effective antidotes to the chemicals they produce for lawn treatment. The suit also asked that warnings be issued to persons using the products to keep children and pets away from treated areas.

"What upsets me is that these big, powerful conglomerates that make so much money would put powerful chemicals on the market without an antidote," Rizzo said. "If they are going to spray your lawn and trees, they should tell you to keep pets and children off it."

Named in the suit, filed by lawyer Richard Sprague, were Du Pont Co., Union Carbide Corp. and Rohm & Haas Co., which Rizzo said manufacture lawn-care chemicals, and Chem-Lawn,the lawn-care company that Rizzo said had taken care of his grounds.

Rizzo said he came down to his kitchen one morning in late July and found his dog "just lying there."

"He wouldn't move," he said. "He usually greets me and jumps all over me. When I went to go near him, he (See RIZZO on 12-A).

#### snapped at me."

Rizzo said that he had taken Casey to Rau Animal Hospital in Jenkintown and that blood and stool samples were taken for diagnosis. Rizzo said the laboratory analysis showed that the dog's stool contained the toxic chemical Kelthane. Kelthane is a miticide used for control of garden pests, such as red spider.

"It was loaded with it," Rizzo said, "and that was the stuff they used on my lawn."

Rizzo said he had contacted poison centers all around the country but had been told that there is no known antidote for Kelthane.

For more than a week, Rizzo said, he took Casey to his longtime veterinarian, Dr. Lee D. Rubin, "every morning at 8 o'clock, and all day long he'd pump fluids into Casey."

Now, about five months later, the Irish terrier, which Rizzo named after a Catholic priest friend, was "coming along, but still not himself," he said.

"Suppose you had a small child," Rizzo said, "and you put the child on a sprayed lawn, and the child licked his hands? I'm positive in my mind that dogs that are dying of liver and kidney problems [are actually] dying of poison.

"People have told me not to take them [the chemical producers] on, that they're too powerful. I'm going to try it. They're not going to back me off."

Carol Butterworth sent in a good example of the new AKC rules regarding the point system. At this printing I do not have the exact rules to include but I will be printing them at a later date.

Example: Glennamaddy Caoimhghin, who was the only class dog at the Upper Marlboro K.C. show at Bowie, Maryland, won Best of Breed over the Specials for a 3 point major under judge, Robert Graham. There was a total of 5 Irish entered and under the new rules if the Best of Breed comes from the classes and goes over any champions, it then counts every dog it defeats. Caoimhghin beat 4 Irish.

(I think this is very good information for our newer members and I am planning on going into the points system in greater detail later.)
