

I know that I do.



### Good News! (for the time being)

Our May '92 Newsletter contained an article from "Dog Watch" about Congressman Benjamin Cardin's proposed Puppy Protection Act, H.R. 3718 (referred to by the press as the "Puppy Lemon Law").

The August '92 issue of the AKC Gazette printed a commentary on this bill, observing (as we all did) that, although its intent is aimed at puppy mills and pet stores, "It most strongly impacts against the people actively involved in producing quality dogs of good temperament and in promoting informed, responsible dog ownership."

This Gazette offered the following encouraging update:

"The AKC Canine Legislation department reports that because of much opposition from the dog fancy nationwide, Cardin has announced he will not pursue H.R. 3718 as introduced. A new bill could be introduced in Congress next January."

Any ITCA members who contacted legislators in opposition to this bill may pat themselves on the back! It'snice to know that if enough of us speak up, we'll be heard!

### Fleeing from Fleas!

Mary O'Brien, President and Editor of ITCNC, reported, in the August issue of her newsletter, on her research into two new products that are considered very promising by scientists at Cornell University. One is an insecticide for dogs ("Defend EXspot"); the other is a bomb insecticide for use in the house ("X-trol").

Mary has located and used both products. She reports that "X-trol bombs" are more expensive than the regular bombs, but they come with a one year guarantee against reinfestation. (No, you don't have to trap fleas to support any complaint you may have! Just save the empty cans and your sales receipt.)

When Mary discovered that "Defend EXspot"'s application method was similar to that of a product she had tried a few years ago (which required rushing Annie to her Vet for emergency treatment), Mary called the manufacturer of "Defend EXspot" for further information. She learned that the earlier product was systemic (absorbed through the skin) whereas this new EXspot is non-systemic (gradually spreading out to cover the skin and a portion of the hair shaft) and should be used once a month.

Annie's home was bombed a month or so ago, and she has recently had her second EXspot treatment. She hasn't seen her Vet all summer and, so far, Mary is delighted! Both products can be ordered from the Foster & Smith catalogue at considerable savings.

# Irish Terrier Breed Rescue

I am happy to report that our two Rescue Dogs are both happily settled into their new homes. I released the dog in the Tucson, Arizona SPCA, "Paddy," after a long telephone conversation with one of the volunteer workers there. She said it was "love at first sight" when she met him, her first meeting with an Irish Terrier. The family had been talking about adopting a second dog, having already adopted a female terrier mix two years earlier. They liked what they read about the Irish Terrier in the AKC Book of Dogs and she had brought her husband, two children and their dog to the Shelter to meet "Paddy," and they all felt he was the dog they wanted. She called me and asked if I would consider releasing the dog to her for adoption. She assured me that they had a well fenced yard and I felt that anyone who had done volunteer work for over four years at an animal shelter would certainly offer a loving home to a rescue dog. They took "Paddy" home as soon as he had his medical check-up and had been neutered. I have had three phone calls since and they are delighted with him and the way he has "taken over" their home and family, including "Peppy," who has also fallen for that Irish charm.

"Murphy," the dog in Salt Lake City, took longer, much longer, to place. It seems that people in that area are not "terrier oriented" and prefer hunting dogs. But thanks to a referral from Morris and Loretta McGuire in Chicago, "Murphy" was flown to Wisconsin a few weeks ago and also appears to be settled in with another loving family. Obviously, rescue networking played a very important part in finally finding a home for "Murphy." "Murphy" probably doesn't realize it, but he owes so much, probably his existence, to Marie Walsh, our member in Utah who fostered him. Marie went beyond just fostering "Murphy," guess you could say she nurtured him. He wasn't considered "adoptable" when she took him from the shelter and Marie had no way of knowing for sure if his temperament problems were genetic or caused by abuse or mishandling. She had him thoroughly checked over by her vet, had him neutered, took him into Obedience, placed him for a while with her daughter so he could be in a one on one situation, worked on socializing him with children and other dogs, and after 14 months felt she could safely say that his temperament problems had been caused by mishandling and were not genetic and that he was certainly now ready for adoption. Only a very special person and a true lover of our "specialdogs" would have expended so much time and effort on a homeless dog who didn't have much going for him. We, and "Murphy," owe Marie a tremendous vote of thanks!

The Club will, I hope, complete setting up our Rescue network across the country at the Annual Meeting next month, and be in touch with all of you who volunteered to serve on the Rescue Committee or to foster a dog if needed. I appreciated your responses and we could use some more, particularly in those areas not covered by a Regional Club.
