#### THE WOMEN RECEIVE THE VOTE AT THE AKC

At the quarterly meeting of the Delegates of the AKC held in March, an all-male assembly of 187 voted overwhelmingly for a motion to amend the by-laws and accept women as delegates. The final vote was 180 in favor and 7 opposed. (Our ITCA delegate, Mike Gately, cast one of those affirmative votes.)

Organized in 1884, the American Kennel Club has excluded by its by-laws the admittance of women as its delegates. In its 90-year history, the matter has been brought up several times before. Twenty-two years ago, a motion to accept women as delegates was soundly beaten. Last December, a proposal of the AKC Board to amend the by-laws was again defeated, but only by 25 ballots.

John A. LaFore, Jr., President of the AKC, made this statement at the March meeting:

"The Board of Directors welcomes the decision of the delegates to amend the by-laws to eliminate the restriction on the election of women delegates. The ladies have always contributed a great deal to the sport of pure-bred dogs and I am sure that they will continue to do so as delegates of the AKC."
