Potpourri Time Again!

Have you noticed the preponderance of Ladies on our Board of Governors? No one can accuse the ITCA of male chauvinism. I think it's great, but then, I've always liked the Ladies.

Please do not consider any relationship between the preceding item and this one. There have been decreases in Irish Terrier registrations at the AKC over the past few years. This has resulted in our breed's going down in ranking with the other breeds. In 1983 registrations numbered 228 as opposed to 312 in 1982. When George Kidd relayed this information to me, we both agreed that it wasn't anything to worry about because quality is more important than quantity. It looks as if the quickest way to ruin a breed is to have it become one of the top ten most popular breeds. Anyway, our breed now ranks 104th out of 128 breeds. In 1964 we were 59th and in 1974, we were 88th.

Our club has over 300 members now and appears strong. We are trying to get new people involved on committees and assignments for the various club functions. We also recognize that not all of our members are breeders or exhibitors, and we are trying to find subjects of interest to them, rather than putting so much emphasis on dog shows. If you have any suggestions on accomplishing this, send them along to Martha Salem, our Newsletter Editor. She will put them to good use.

Lastly, remember that the steam kettle, although up to its neck in hot water, continues to sing. Have a wonderful summer!

REPORT OF THE "HEALTH OF THE DOG" COMMITTEE

The organizing of the Committee on the "Health of the Dog" is progressing. The purpose of the committee, as stated in the May Newsletter, is to search out what, if any, genetic or apparently inherited defects there are in the Breed, at this time. It is hoped that we shall find our breed in the same state of good health it has enjoyed over the years.

However, recent articles indicate that abnormalities are being found in purebred dogs after years of breeding. We read further that in some breeds, the standards have been found to hinder physiological functions of organs and parts of the body. Breeders of Irish Terriers must be aware of such possibilities and, to this end, the Irish Terrier Club of America shows very forward thinking in requesting that a survey be made.

Finally I said, 'Andy, it seems to me you get angry whether you win or lose,' at which he said, 'Begob, maybe I do.' "

President Sayres also wrote a reminder that ITCA will support the American Kennel Club's Centennial Show in Philadelphia on November 17 & 18, 1984, where our Irish will be judged by Dennis Barnes. Aside from this grand show, a whole week of festive and informative events has been planned! World Congress meetings will be held on November 12, 13, and 14. The University of Pennsylvania's School of Veterinary Medicine will offer tours of its facilities on November 15 and 16 (as reported on page 12 of your March Newsletter). Acupuncture is now being used by about 400 veterinarians nationwide. One of the most prominent of these is Dr. Sheldon Altman of Burbank, CA. The primary aim of veterinary acupuncture is to stimulate and strengthen the body's adaptive/homeostatic mechanisms. It is known to have effects on all the major body systems and good therapeutic value in a wide variety of animal diseases. However, it is far from being a panacea, and considerable experience is needed before it can be practiced satisfactorily with optimum results. 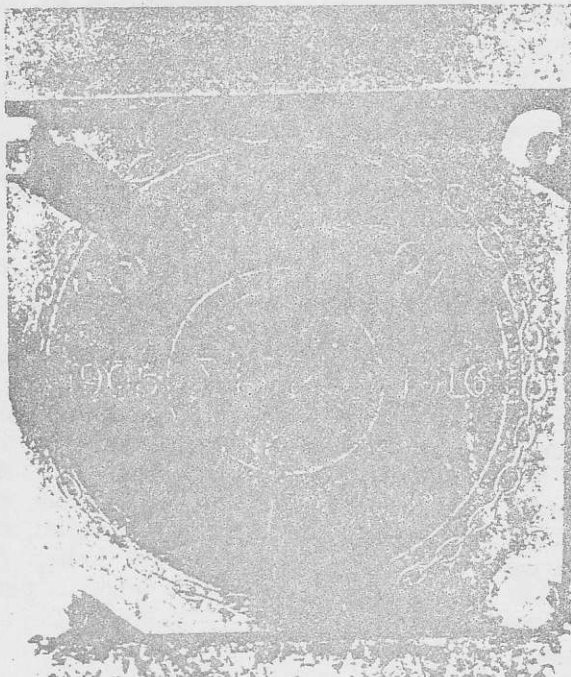

Mike's Monument

Parris Island's most famous mascot was a full-blooded Irish terrier who specialized in chasing rabbits and fire engines while defending his terrain at all costs. When he died in 1916, the Marines took up a collection for their faithful dog's gravestone.

The United States Marine Corps and its posts and stations have claimed numerous canine mascots over the years, some of whom, unfortunately, may have been forgotten by now. The Corps' dogs have accompanied the Marines on land and sea, and probably in the air. They have also attained ranks as prestigious as canine sergeant major and have been issued resplendent uniforms and service record books.

Jiggs I was a national celebrity who was acquired by General Smedley D. Butler in 1921. Heavyweight boxing champion and former Marine Gene Tunney donated Jiggs II to the Corps, while as many as five other mascots have carried the Jiggs name over the years. Private Padgett was donated to the Corps by the British Royal Marines, and

the "Chesty" clan has served as Marine mascots in more recent years.

Each Marine Corps post has been at one time or another the home of other canine pets, and Parris Island is well represented as a "choice duty station" for them. Duke, for instance, was a Great Dane and a World War II veteran that belonged to Major General Clayton B. Vogel, who commanded the recruit depot from 1944 to 1946.

Skipper was MGySgt Leland Diamond's dog when "Lou" was the non-commissioned officer in charge of the hygienic building at the recruit depot. But, without question, Parris Island's most famous dog was Mike. According to *The Marines' Magazine* of April 1916, he was known by hearsay, or "personally acquainted" with, "more than half of the men in the Marine Corps."

Mike was born in the kennels of a Marine Corps colonel (Waller) in Williamsburg, Va., on June 5, 1905. In 1909, he spent several weeks in Guantanamo, Cuba, where he "chased tropical lizards..." He next reported to Annapolis, Md., "for a short stay" in 1910, at which time he patrolled the rifle range.

By then it appears that the full-blooded Irish terrier had learned to recognize all the military bugle calls. Whenever "fire call" was sounded Mike would arouse all the stragglers in camp and report to the scene before the engines arrived.

Mike was next "ordered" to the Norfolk, Va., Marine Corps recruit encampment. There he regularly attended all parades and "picked up the trail of the scouting party" on maneuvers in the field. Certainly, by 1913, the dog was combat trained and prepared to go to war. That possibility became a reality in the following year.

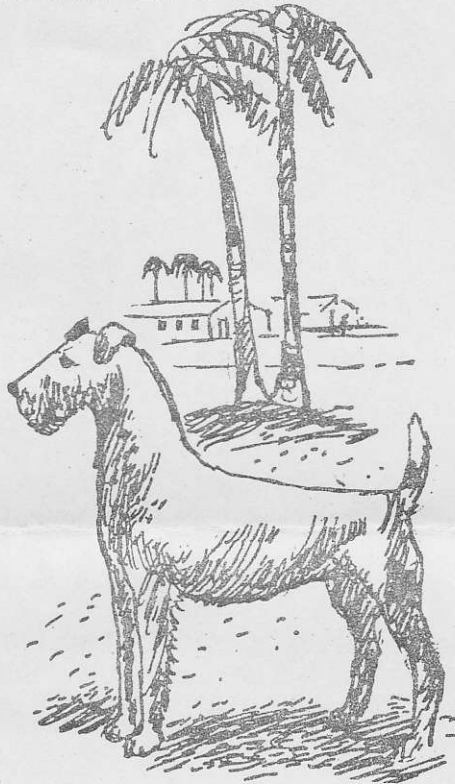
When diplomatic relations between Mexico and the United States deteriorated to a low point in 1914, Mike accompanied "Company D, 2nd Bart" [the regiment is unspecified], on board the USS *Hancock* to Vera Cruz, Mexico, where he landed with the Marines on April 21. On that and the following day, Mike took part in an "engagement that led up to the taking of Vera Cruz." He then helped patrol the streets until April 30, when he embarked on the *Hancock* to return to Norfolk, where he served at the recruit training encampment until 1915.

As a "combat" veteran, Mike found garrison duty to be rather tame. His only service blemish until then had been "irreverent conduct in church" in November 1913, for which he was "warned." Mike went astray again in December 1914

when "he chewed and scratched up a ditty box," for which he "was awarded one swift kick."

On March 10, 1915, Mike "created a disturbance in camp after taps" by engaging in combat with a strange dog. For this, Mike "was tried by court-martial, and sentenced to lose one soup bone."

Perhaps old Mike was burned out and needed another, more challenging assignment in the Corps. That good fortune occurred in October 1915 when the Norfolk Marines were ordered to strike their tents and prepare to put to sea. Their destination was Parris Island, on the South Carolina coast.



When Mike disembarked from the USS *Prairie*, moored off Parris Island, he must have viewed it as a canine paradise. The old Port Royal Naval Station acreage and its Naval Disciplinary Barracks were thickly populated with otters, rabbits and squirrels for Mike to pursue. The presence of southeastern diamond-back rattlesnakes and alligators on the island added an element of adventure to the dog's life, along with the chance that he might even be summoned to track down a naval prisoner who had escaped from the brig.

Unfortunately, the voyage from Norfolk to Parris Island, the unloading of the *Prairie*, and the excitement of commissioning a permanent Marine Corps recruit training camp may have been too much for the ten-year-old dog. By January 1916, Mike was taken ill and was "unable to follow the drill companies to the parade ground."

A collection was taken up by the Marines to send the dog to a veterinary hospital in Savannah, Ga., but on February 5, 1916, Mike died. His comrades would not allow the old campaigner to be buried in Savannah, and his remains were returned to Parris Island on board the tug *Pilot Boy*.

The "last remains of this faithful and loyal mascot of the recruit depot were put to rest in a nice grassy plot" on the south side of the old Parris Island timber dry dock, which had once served the mightiest warships of the United States. Across the street from Mike's grave was the commanding officer's depot residence, now designated as Quarters #1.

An appropriate gravestone for Mike was designed and constructed by a 1915-1917 Marine, John C. Bush. The conspicuous marker was "composed of cement, mixed with blue paint, to give it a marble effect," and the stone was several feet high. Later, as a civilian, Bush was in charge of all the island's masonry until 1923. Constructing Mike's gravestone had been his most "beloved" accomplishment. On the front of the stone was placed "a brass plate with a short biography" of Mike, which was etched by the depot's GySgt Gustaf Brodstrom, of Norfolk, Va. All funds for the stone and the brass plate were "raised by popular subscription" from Marines.

Moreover, tributes were awarded to Mike in *The Recruiters' Bulletin* and in *The Marines' Magazine*. In March 1916 the *Bulletin* declared that "Mike was a true Marine," that he was "a true friend," and that he "never gossiped, never lied about a friend," and "may his bones rest in peace."

For years Mike's grave stood alone until other dogs were buried beside him. But none of them had the stature of Mike. Since Mike's death, several depot commanding generals who later became Commandant have viewed the dog's grave site from the front porch of Quarters #1. Untold numbers of Marines have marched past Mike's grave over the years to the depot's docks, en route to battles and campaigns that are now a part of the history of the USMC.

More recently, the Parris Island dry dock and several of the historical buildings adjacent to the slip have been placed on the National Register of historical sites, to be protected from destruction in future years. Mike's final resting place, and his gravestone, which is the oldest standing monument on Parris Island, are included on the Register, too. Mike is, indeed, a famous dog in the Corps.
