## PRESIDENT'S COLUMN

The Education of Dog Judges -

For as long as I can remember, all dog exhibitors and especially Irish Terrier breeders, have echoed the complaint that most judges, while licensed to judge Irish Terriers, do not really "know" this breed. How could they?

To their credit, the American Kennel Club is taking steps to remedy the situation. While there is no substitute for breeding, showing, and living with our breed, the AKC has implemented programs to at least make our breed more familiar to judges.

To supplement just reading breed literature, attending judging seminars, and studying the standard, the AKC is sponsoring sound/slide presentations of all breeds. This latest attempt to get more information to the judges, while not perfect, is a good educational tool, and will become even better when the video taping mode becomes part of the process.

Your Board of Governors voted at the October, 1982, meeting to cooperate with the AKC in this endeavor. Prior to this, we had participated in a seminar in Chicago, sponsored by the Dog Judges' Association of America. The club also has opted to participate in the Dog Judges' Association's exhibition and seminar to be held in Philadelphia prior to the AKC's Centennial Show next November.

Our participation in the slide show program is progressing slowly. The first photography session took place at last February's Specialty. More sessions are planned at the Chicago regional club's Specialty in JUne, at our Traveling Specialty in California, also in June, and at our National Specialty next October. As you can see, this is a very slowmoving project, but the results should be worthwhile.

The committee's first report to the AKC is published elsewhere in this Newsletter. The report was approved by the Board of Governors. Each and every step that the AKC takes will be in cooperation with our committee, and any material that is published will have the final approval of the committee and the Board.

We are constantly trying to educate judges so that they will become more familiar with our breed and gain more knowledge of Irish Terriers. This can result only in better decisions in the ring, and ultimately in the development of dogs that are closer to the standard of the breed.

#### NEW POLICY FROM ITCA'S BOARD OF GOVERNORS

Method for reporting, verifying and tallying obedience scores for the annual obedience award of the Irish Terrier Club of America.

The publication year of the American Kennel Club Show, Obedience and Field Trial Awards will be considered the year for detemining the annual Irish Terrier Club of America obedience award. Three qualifying scores must be published in this year for a dog to be considered for this award. It shall be the responsibility of the owner(s) of the dog to report scores, with the name and date of the trial, to the compiler of annual award statistics. To be considered, a score must be attained on a date on which the owner(s) is (are) members in good standing of the Irish Terrier Club of America. In case of a difference between the score as reported and as published, the compiler shall inform the owner(s) of the dog in question, and it shall be the responsibility of the owner(s) to ascertain the correct score from the American Kennel Club and inform the compiler of this correct score. The three highest scores obtained by a dog shall continue to be used in determining the annual award. If a dog has scores higher than a score needing verification, the owner(s) may so inform the compiler and thereby not verify scores which are not needed for the publication year in question.

#### JUDGES' EDUCATIONAL COMMITTEE REPORT FOR THE AKC

A. A list of things (faults, virtues, unique attributes) that are important to point out to judges:

Overall appearance to be graceful with no cobbiness. The Irish Terrier must convey character and alertness, and have great animation. He must have a racing ourline with a longer back than other terriers. His topline should be straight except for a trace of a rise over the loin.

The head should be balanced, having a flat skull rather narrow between the ears, being wedge-shaped and narrowing slightly toward the eyes, and being free of wrinkles. Ears should be small, well set on the head but carried not too high or low, and dropping forward closely toward the outside corner of the eye. Hound like ears should be severely penalized. Eyes should be small and dark with a piercing expression.

Coat should be wiry and dense, with undercoat. Color should be solid; any shade from wheaten to bright red is equally desirable. Furnishings should not be soft or profuse, but of similar texture to that on the body, to give proper finish to the dog.

Irish Terriers should have strong rear quarters with a lot of drive in motion.

The bite, a scissors type, should be neither overshot nor undershot, with the inside surfaces of the upper incisors in close proximity to the outer surfaces of the lower incisors when the mouth is closed.

Feet should be free of corns which are a most serious fault.

The size of the Irish Terrier, as stipulated by the standard, is for dogs to weigh 27 lbs. and bitches 25 lbs. The height at the shoulder should be approximately 18 inches. These figures should be used as a guide, but the judge can tell an oversized Irish Terrier by its conformation and general appearance. Several members of our Board of Governors have expressed their concern that judges are not paying enough attention to the section on size in our Standard.

Sparring in the ring is a natural manifestation of the Irish Terrier's instinct to challenge other dogs, particularly of the same sex.





#### SECRETARY'S REPORT

By a vote of 119-5, the change in the Bylaws was approved by ITCA members. The change has been approved by the American Kennel Club and is now official. The wording in part I, section 4 (b) now reads: "A membership will be considered as lapsed and automatically terminated if such member's dues remain unpaid 60 days after the first day of the fiscal year. In no case may a person . . . "

The new roster is ready to be mailed out. This year we have 301 members, with three more pending; if memberships continue to come in at the current rate, we should reach an all-time high number of members this year! Technology is being put to work this year as the roster is being recorded and printed by computer. Up-to-date mailing lists will be able to be printed quickly and hopefully address changes, additions to the membership and next year's roster can be revised and printed with speed and accuracy.

The Board has acted on several very important items since the last Newsletter.

First, please note the new method of reporting obedience scores for the annual trophy shown elsewhere in this Newsletter. The Board voted 14-1 to approve this method. Those of you who are now or who plan to enter your dog in obedience will be responsible for reporting the scores to the compiler. The current compiler is Jim Thomas, 1145 Oakheath Drive, Harbor City, CA 90710.

The Board voted on several items pertaining to Montgomery County. First, the classes this year will be held in memory of Ed Chojnowski, who passed away last fall. The Board voted to ask Jim Sybor to judge the Sweepstakes at this year's Montgomery County show in October. Jim has enthusiastically accepted. He is a former member of the ITCA, and many of you will recognize him from ringside at eastern dog shows. Jim is quite experienced in judging sweeps, and was last year's wire fox sweepstakes judge.at the same show.

Technology will also be used this fall at the Montgomery County specialty. In a 12-3 vote, the Board has decided to videotape the entry at this year's show. Although the final details have not been worked out, these tapes may possibly be used for the Judicial Education Committee and also be made available to regional clubs and those who are not able to attend the show. Certainly these tapes will be extremely valuable in the future--how wonderful it would be to be able to see tapes of the great dogs of the past!

Finally, the Board scheduled their meetings at this year's specialty weekend so that they will have more time to join in the festivities--no more meetings until the wee hours of the morning! The general membership meeting will be held on Saturday afternoon, but more details will be made available as plans are finalized.

Lastly, the Board unanimously agreed to set up a committee to study possible genetic defects of our breed. It is hoped that Irish Terriers are generally healthy, but the time to correct problems is before they become widespread. Mrs. Isabelle O'Connor will chair the committee, and three veterinarians in the Club (Dr. Joseph Sayres, Dr. Marianne Carson and Dr. Gary Johnson) will serve as advisors to the committee. Later this year you will be receiving more information from this committee.

# pet q&a by ANNA P. CLARKE DVM

Q: A veterinarian told me recently that when "surgical risk" is mentioned, in most cases it is the anesthetic that entails more risk than the surgery. If an anesthetic just puts an animal to sleep, what is the risk? —M.G.

A: Despite the commonly used expression "putting to sleep," anesthesia is not the same as sleep at all. Anesthesia is a state of unconsciousness that produces reversible depression of the nervous system. When an anesthetic is given, the muscles relax, the heart and respiratory rate slow down, the temperature drops, pain cannot be felt, and all body systems are depressed. In that state, the body is only one level above death, and that is why anesthesia carries with it some risk.

Anesthesiology is considered an art as well as a science, because, weight for weight, different animals respond differently to the same dosage. In veterinary medicine, the risk of an unforeseen reaction is not high for several reasons. Veterinarians are thoroughly trained in anesthesiology; they administer anesthetics daily in practice; they give all animals a careful pre-anesthetic examination; they closely monitor the respiratory rate, heart rate, blood pressure and reflexes during anesthesia, and they constantly adjust the dosage to keep the animal pain-free and relaxed but not too-deeply anesthetized.

Despite all such precautions, about one out of every 10,000 animals anesthetized will die through no fault of the veterinarian or the veterinary hospital. That is a statistical likelihood that cannot be diminished at present, despite the continuing development of newer and safer anesthetics. Most of these deaths occur in old, sick or injured animals, but occasionally an apparently healthy animal will succumb.

Q: My dog loves to eat chocolate. Any harm in that? - R.W.

A: Until recently, most veterinarians believed that it was all right to feed a dog chocolate occasionally. However, chocolate contains theobromine, a caffeine-related stimulant that can cause loss of urine control, seizures and death in dogs. Dogs do not excrete theobromine from their bodies as quickly as people do, so poisonous levels can accumulate in their system. If not treated, this can have fatal consequences. In light of that information, it is suggested that you do not feed chocolate to your dog in the future. pet q&a by anna P. CLARKE DVM

Q: Because I work long hours, I usually don't notice symptoms of illness in my pets until after regular veterinary office hours. How can I determine wether a sick animal needs emergency veterinary care or whether it can wait until the next day? —T.T.

A: It is not always easy for a pet owner to determine whether a pet's illness is minor, serious or a genuine emergency. The following guidelines should help.

Symptoms of minor illness that usually do not require immediate veterinary care include loss of appetite for not more than one day, or a change in appetite; behavior that's quieter than usual for a few days; excessive drinking and urination if the pet is otherwise healthy; mild vomiting and diarrhea not accompanied by depression, or a temperature between 102 and 104 degrees Fahrenheit (101.5 is normal).

Symptoms of serious illness that require next-day veterinary care include complete loss of appetite; gradual or sudden loss of weight; vomiting or diarrhea occurring more than twice, or continuing for more than one day, or if bloody or foul-smelling; sudden excessive urination, or none, or straining to urinate; dehydration, recognizable by sunken and dry eyes, a dry mouth and loss of elasticity of the skin; a temperature of more than 104 degrees; severe depression or excitability; pain; controllable bleeding; white or bluish gums; heart rate increased or decreased from normal, or weak or irregular breathing that is increased or decreased from normal, or labored; muscle tremors, or one convulsion or fit of less than three minutes duration.

Emergencies that require immediate veterinary care include cardiac or respiratory arrest, all serious accidents or injuries, unconsciousness, shock, poisonings or suspected poisonings, uncontrollable external or internal bleeding, fractures, paralysis, eclampsia (milk fever) in nursing mothers, severe allergic reactions, temperature over 106 degrees, stomach torsion and dilation, or a seizure that lasts more than three minutes.

Remember, these are only guidelines. A pet's minor illness can become an emergency in a matter of hours, so if you are in doubt, be sure to telephone your veterinarian.
