PRESIDENT'S MESSAGE

Annual registrations of Irish Terriers continue to range from 250 to 300 dogs per year. Approximately 70 to 90 litters are bred each year with an average of 3.3 to 3.5 puppies registered from each litter. Individual registrations for 1987 were down slightly to 227. Litter registrations were a bit low at 68. Out of the AKC's 129 recognized breeds, the Irish ranked 108th in individual registrations and 105th in litter registrations.

During the past six years the registration numbers have fluctuated some, but no clear changes in breeding trends have surfaced. 1982 and 1984 had high numbers of individual registrations with 312 and 299 respectively. 1983, 1985, and 1987 had low numbers with 228, 235, and 227. 1986 produced numbers right at the six year average for the breed with 261 individual registrations and 75 litter registrations.

The years 1982 through 1986 produced both increased membership in the Irish Terrier Club, and entries at our national specialties. With the breeding trends remaining fairly constant, it appears that breeders are not interested in breeding more dogs, but instead are interested in increased participation in the sport. We hope this raises the knowledgeability of our breeders and maintains the quality of our breed. If that is what it means, then the years ahead look bright for the Irish Terrier.

Secretary's Report

Since the last edition of the ITCA Newsletter your Board of Governors have voted on several matters.

The ITCA previously selected J. MacDonald, J. Wilson and E. West to be our club's representatives to make decisions relative to the AKC video project. These three people will need to travel to New York City twice in connection with this project. Your Board voted to reimburse these "reps" for actual transportation and lodging costs up to a suggested maximum of \$500 per person for the entire term of this assignment.

The Board of the ITCA voted to send a letter (copy attached) to the AKC opposing their recommended program to standardize the breed standards.

The board of the ITCA voted to approve a \$24.00 fee to cover the cost of the annual dinner, a deli like spread in the hotel hospitality room and coffee and doughnuts Sunday morning ringside at the 1988 Montgomery Specialty Show. We await approval of this last item from the Montgomery County Kennel Club.

Your Board is in the process of voting on several other items which will be communicated to you in our next newsletter.

Sample draft to the American Kennel Club

Dear Sirs:

The Irish Terrier Club of America has given full consideration to the American Kennel Club's recommended program to standardize the breed standards. Our membership was exposed to the program at our annual meeting in 1986. They were quite critical of it. Our Judges Education Committee reviewed the AKC materials in depth and voted unanimously to oppose the program. Their recommendation was forwarded to the ITCA Board of Governors. The ITCA Board voted to oppose the program.

The primary point of concern is that the responsibility for development, protection, and promotion of the Irish Terrier is the province of the Irish Terrier Club. The ITCA does not wish to relinquish this responsibility.

The ITCA also felt that the standardization program would not improve judging. The concensus was that standardization would trivialize the differences between the breeds. This program might assist judges with minimal abilities to increase their range of activities by focusing on the similarities of breeds rather than the differences.

The ITCA feels that the burden for developing judging skills ought to rest upon the individual who wishes to become a judge. Judging is a voluntary avocation. Therefore, these individuals ought to be encouraged to take the initiative to observe the breed in the show ring and discuss the breed with breeders. This pursuit of hands-on knowledge is, at present, a rarity. The standardization program will do nothing to encourage it. The ITCA would like to see the AKC move towards a hands-on judges training in order to improve the quality of judges.

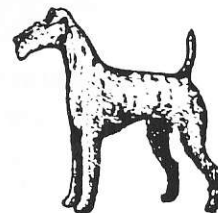

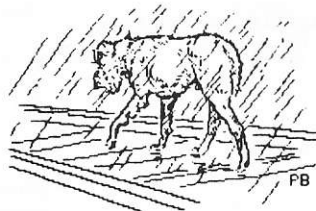

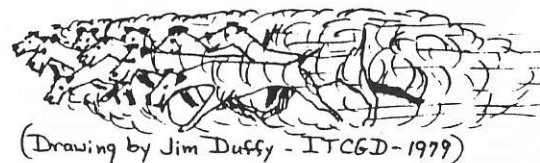
