The ITCA Specialty show February 10, 1974, will be dedicated to the memory of Jeremiah J. O'Callaghan. The Board of Governors made this decision to honor our distinguished member shortly after learning of Jerry's death October 15, at age 87.

The Specialty will be held at the usual location, the State Armory, 216 Fort Washington Ave., near 168th St. and Broadway, New York City, as part of the Associated Terrier Clubs annual show.

The Presbyterian Hospital parking lot, 165th St. and Fort Washington Ave, one block south of the Armory, will be available for parking of Exhibitors' cars. This lot will be open Saturday from 6 a.m. to Sunday 2 a.m., then from Sunday 6 a.m. to 12 midnight. Regular parking fee will be charged. Exhibitors with crates may use the ramp at the 169th St. entrance (west bound traffic, and may be entered from Broadway only). Exhibitors with dogs on leashes and with portable equipment may enter at the door on 168th St., which is a two-way street.

Irish Terriers will be judged at 10 a.m. Our judge will be Robert Marshall, of New York City. After the judging, the ITCA will again have an informal luncheon, provided by several members of the Club, in one of the classrooms of the Armory. After lunch, President Mike Gately will call to order the annual meeting of the ITCA.

A feature of the Jeremiah J. O'Callaghan Memorial Specialty will be the awarding for the first time of the Martha G. Hall Memorial Trophy for Best of Breed, a beautiful 16-inch Sterling Silver tray. This trophy is being offered by friends of Mrs. Hall through the ITCA. The Board of Governors has set the following conditions to govern competition for the Trophy:

- Will be offered annually for Best Irish Terrier at the ITCA New Fork Specialty show.
- Ownership and possession will be retained by the ITCA until the Trophy is retired by virtue of having been won three times by the same person (or persons in case of joint ownership) not necessarily with the same Irish Terrier.
- ITCA will have engraved on the Trophy at ITCA expense, annually, name of the Irish Terrier judged Best of Breed at said show, also name of the owner (or owners) and the year.

- ITCA will award outright, annually, a small Sterling Silver replica of the Trophy to the winner of a leg on said Trophy except for the 3d leg won by the same person or persons.
- ITCA will display the Trophy each year (until its retirement) in the Irish Terrier ring during the Irish Terrier judging at the New York Specialty.
- Any problems that arise concerning the Martha G. Hall Memorial Trophy will be resolved by the ITCA Board of Governors.

Jeremiah J. O'Callaghan Memorial Fund

Jerry O'Callaghan died October 15, 1973. For most of three-quarters of a century he applied himself to the breeding of ever better Irish Terriers. This memorial fund is a recognition of his unique contribution to the *rish Terrier breed.

Quotes from Other Columnists. Fopular Dogs, September 1973, page 36, Article titled "How Can the English Continue to Breed Quality Terriers?" by John Marvin.

- "...In England, breeding comes first while a winning record on this dog or that one is a secondary consideration. In America, the exact opposite is true so far as the great majority is concerned. In England, the average span of a Terrier fancier's interest is several decedes and in some instances becomes a second or third generation effort. In America, according to reliable statistics, the average span of interest is only about five years. A person obtains a good dog, shows it to advantage; tries to breed or buy another, fails, and leaves the fancy -- a transient casualty that was probably not much interested in the beginning except for the acclaim his dog brought to him...
- "...The English love competition and support their shows well BUT making champions, winning groups and Best in Shows is always secondary to breeding quality dogs.
- "...In general, they do not breed to the top winner as so often is the case over here. They do breed to a dog that has the proper bloodlines and who is producing well with bitches of the type of their own -- he may or may not be a champion..."

We have received a very nice letter from Jerry O'Callaghan's sister, Mrs. Nora O'Callaghan Dacey, thanking the members of the Irish Terrier Club of America for the Club's expressions of condolence at Jerry's death.

Answer to a query. In the October 1973 Bulletin we asked whether any Irish Terrier other than Ann Cook's bitch has won High in Trial in obedience, and whether any Irish Terrier has ever scored higher than John Childers' Ch. Gloccomara Gallan with a 196.33 average. John Best replied:

"Turfbreeze Barrister, an Irish Terrier bred by Ed O'Keefe and owned by John Powers, was entered in the Novice A Class at Wisconsin Kennel Club on January 29, 1961, and was highest dog in trial with a score of $199\frac{1}{2}$. I am enclosing a copy of a clipping from the Milwaukee Journal of Monday, January 30, 1961. There were 122 entries in the trial.

"As to the highest average of three scores for an Trish Terrier, my records indicate that (Ch. Gloccomara) Gallan had three scores of 195.5, 197.5 and 195.5 for an average of 196.167. My records go back to 1933 and I have nothing showing a higher average for three trials in a single trophy year. The closest that I have is Pagan Queen Taffy, which had an average of 195.83 in 1964."
