The following article comes from Peggy Gill. When Peg isn't busy with puppy referrals, she works as a bio-chemist. This information comes from reading, and from talking with Dr. Peter Hardy, D.V.M., of the Concord Animal Hospital in Concord, Massachusetts, whose field of expertise this is.

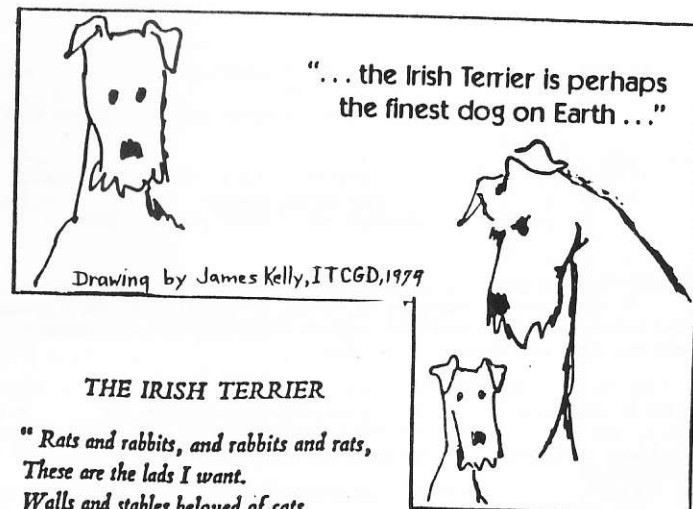
Dear Martha,

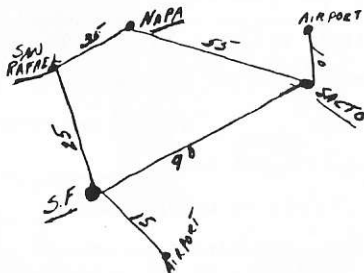

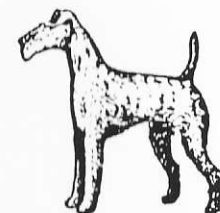
